# New Appraisal Drill – Jarrar 6 Naccowlah Block

Bounty Oil & Gas NL (Bounty) reports commencement of the 2020 oil appraisal and exploration program at the Naccowlah Block, SW Queensland.

A further well; Jarrar 6 will be spudded today, 16 January 2020.

Jarrar 6 is located in Jarrar Field; PL 77 Naccowlah Block approximately 18 km southwest of the Jackson Oil Facility. (See Figure 1). The well will be drilled with the Ensign 967 rig.

#### Well details - Jarrar 6:-

Jarrar 6 is a vertical (J shaped) development well with planned total depth of 1809 metres MDRT designed to test for and further appraise the Birkhead oil zone.

Location: Latitude - 27 degrees 42 minutes 57.41" South


Longitude - 142 degrees 12 minutes 20.72" East
